About the fund

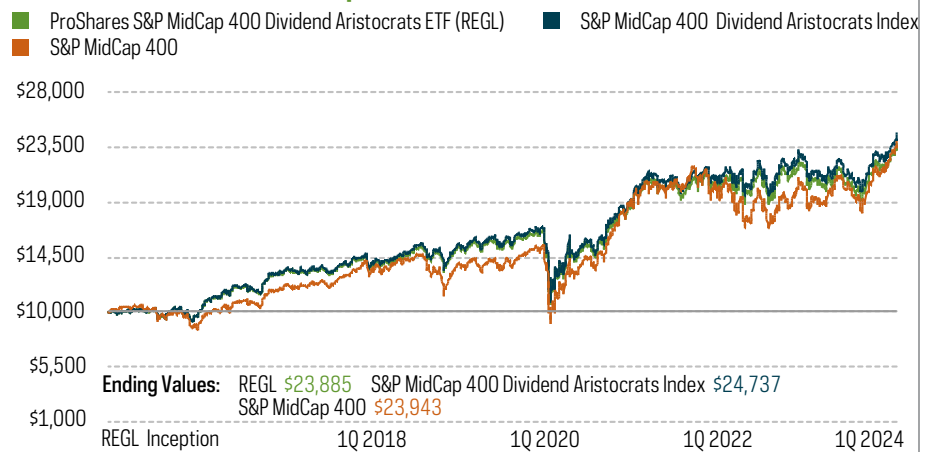
