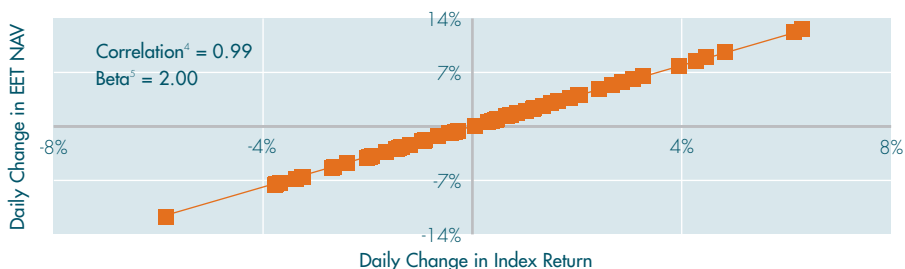
## FUND PERFORMANCE AND INDEX HISTORY

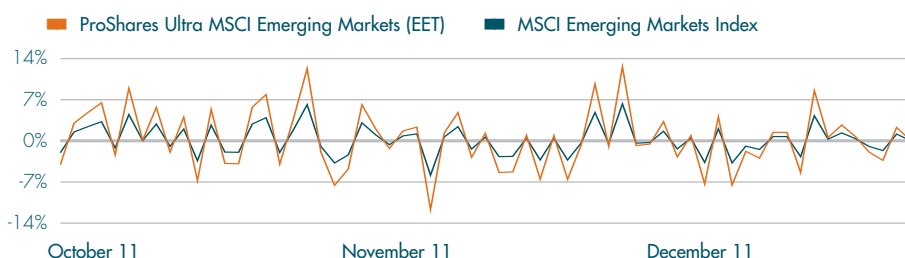

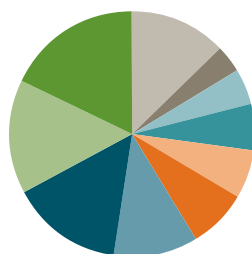
