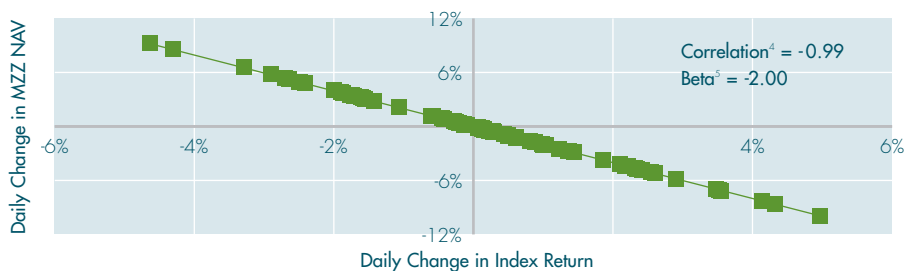
FUND PERFORMANCE AND INDEX HISTORY

ProShares UltraShort MidCap400 seeks a return that is -2x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. These effects may be more pronounced in funds with larger or inverse multiples and in funds with volatile benchmarks. 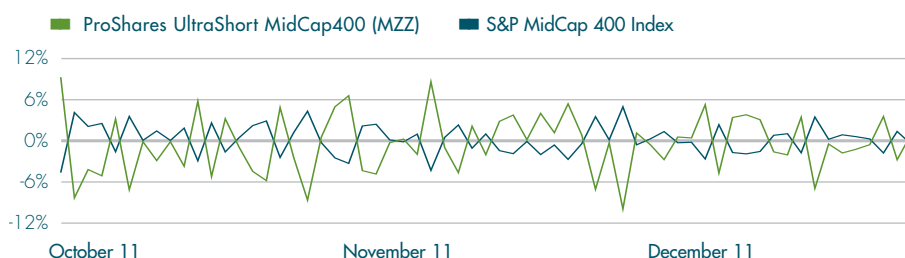

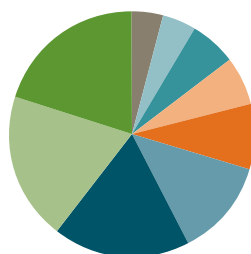
