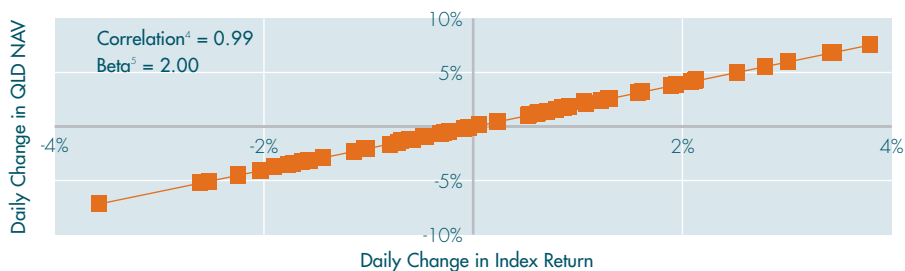
### FUND PERFORMANCE AND INDEX HISTORY

ProShares Ultra QQQ seeks a return that is 2x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. 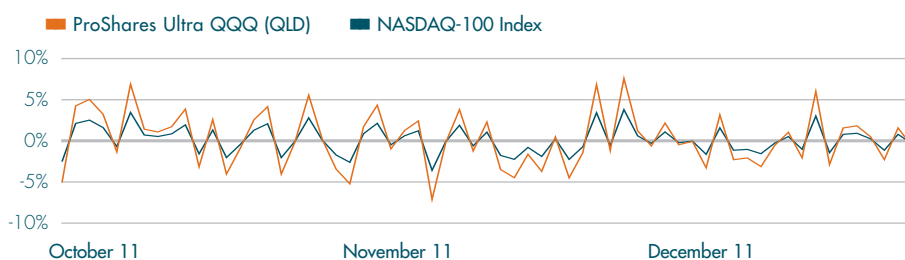

Companies selected for inclusion are non-financial companies currently not in bankruptcy proceedings with appropriate trading volumes and adjusted market capitalization.

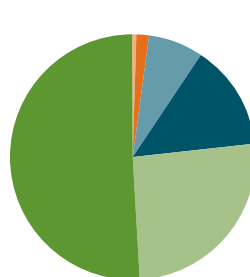
