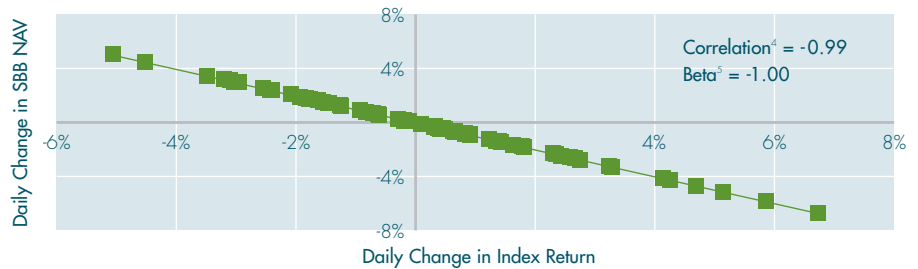
## FUND PERFORMANCE AND INDEX HISTORY

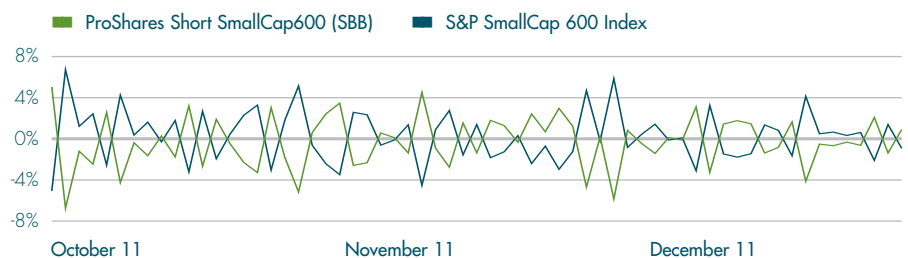

The S&P SmallCap 600 Index covers the small-cap segment of the U.S. equities market, covering approximately 3% of the U.S. equities market.

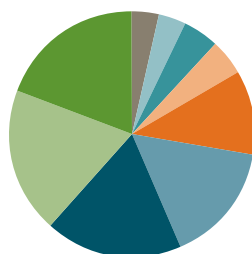
