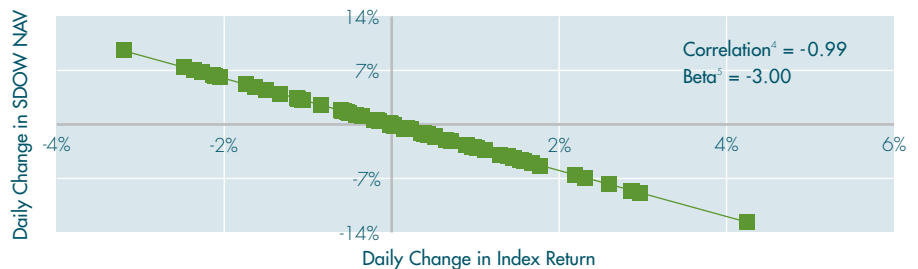
FUND PERFORMANCE AND INDEX HISTORY

ProShares UltraPro Short Dow30 seeks a return that is -3x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. 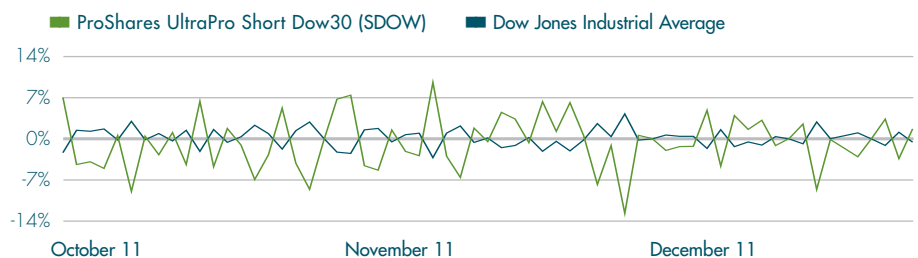

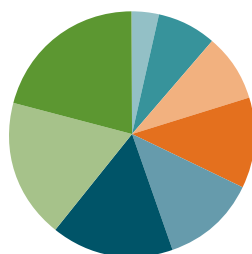
