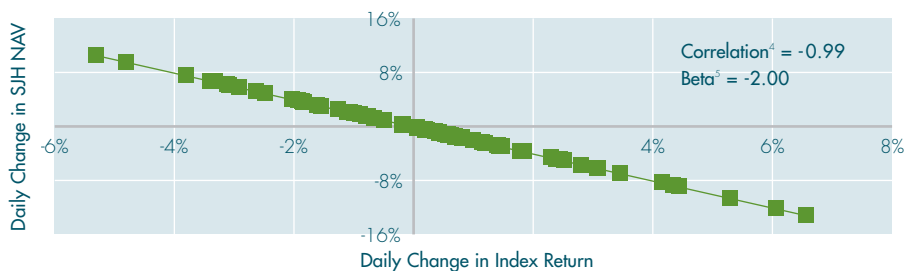
### FUND PERFORMANCE AND INDEX HISTORY

ProShares UltraShort Russell2000 Value seeks a return that is -2x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. 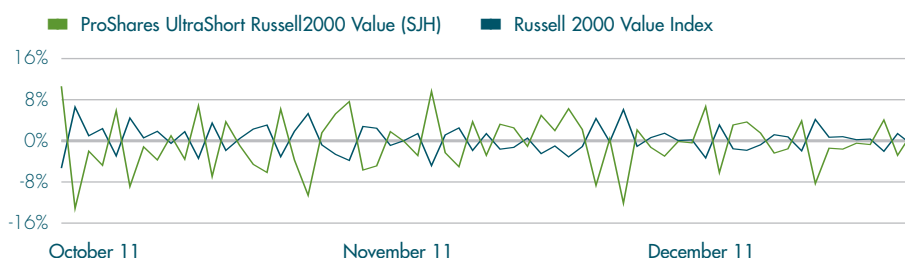

The Russell 2000 Value Index measures the performance of those Russell 2000® companies with lower price-to-book ratios and lower forecasted growth values.

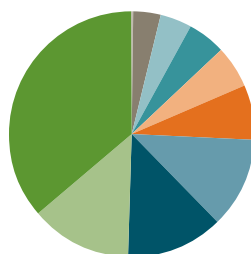
