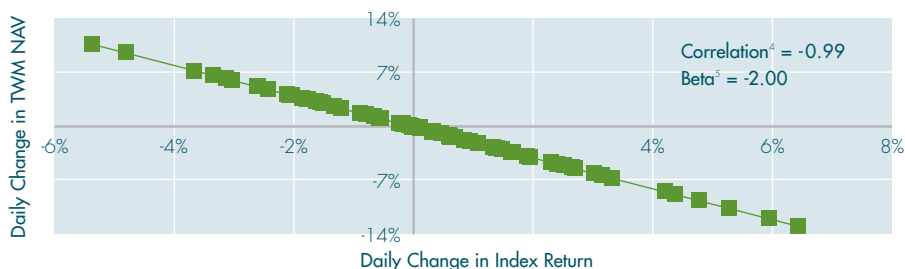
FUND PERFORMANCE AND INDEX HISTORY

ProShares UltraShort Russell2000 seeks a return that is -2x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. 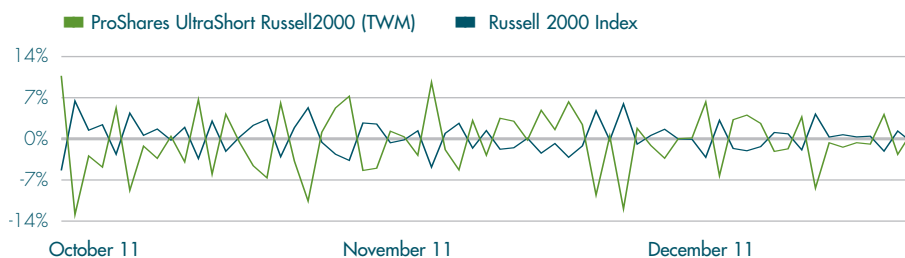

The Russell 2000 Index consists of 2,000 of the smallest U.S.-domiciled, publicly traded common stocks included in the Russell 3000[®] Index.

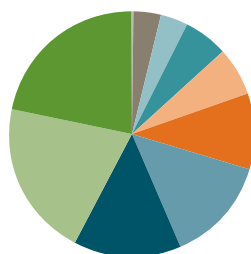
