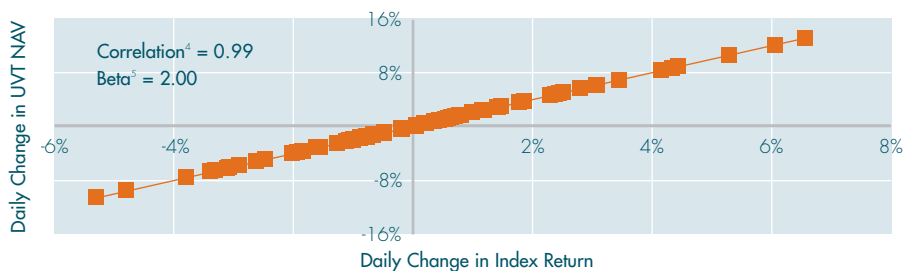
FUND PERFORMANCE AND INDEX HISTORY

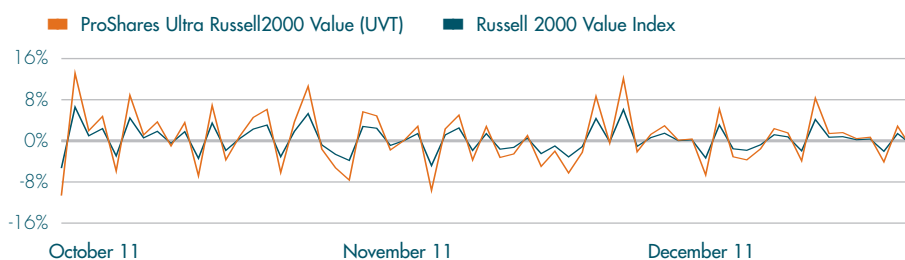

The Russell 2000 Value Index measures the performance of those Russell 2000® companies with lower price-to-book ratios and lower forecasted growth values.

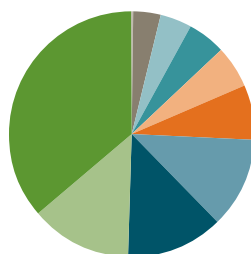
