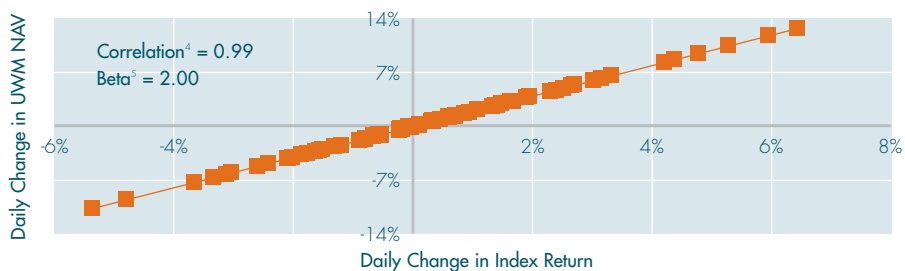
### FUND PERFORMANCE AND INDEX HISTORY

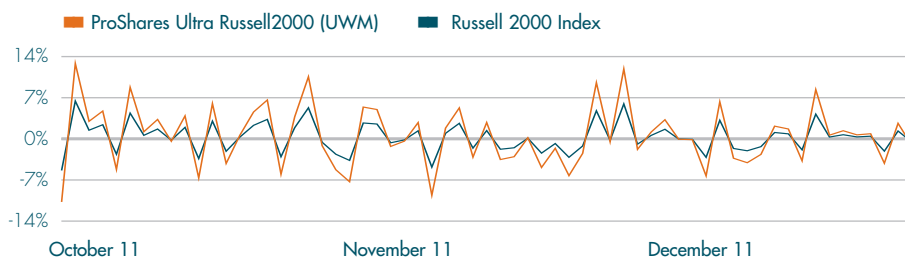

The Russell 2000 Index consists of 2,000 of the smallest U.S.-domiciled, publicly traded common stocks included in the Russell 3000® Index.

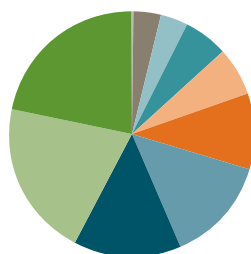
