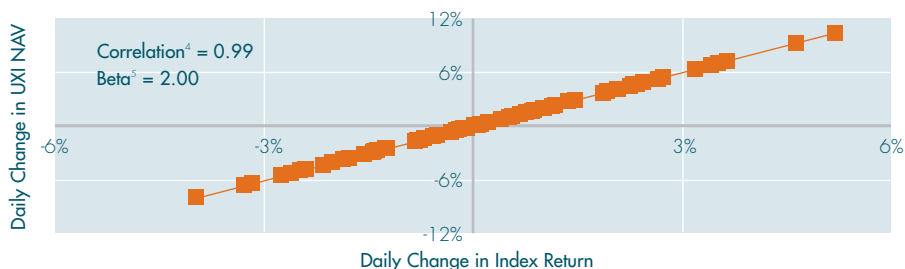
### FUND PERFORMANCE AND INDEX HISTORY

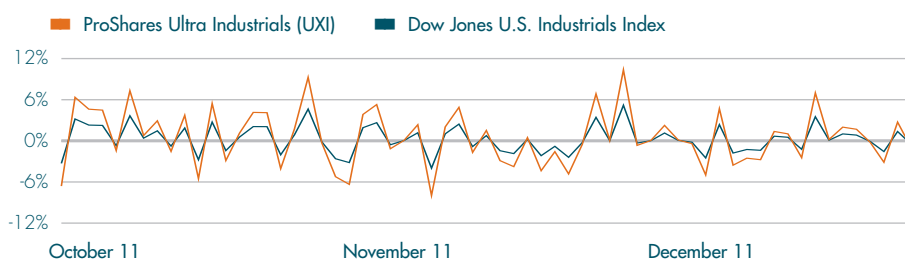

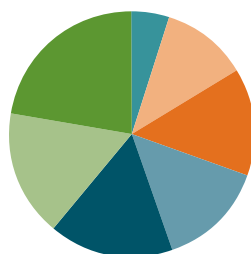
