

## How Did the Fund Perform Last Year?

Russell 2000 High Income ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the Cboe Russell 2000 Daily Covered Call Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. For the period September 4, 2024, through May 31, 2025, the Fund had a total return of -2.26%. For the same period, the Index had a total return of -1.74% and a volatility of 22.06%. Premium income drove slight outperformance compared to the Russell 2000. Primary factors affecting Fund performance include the total return of the securities held by the Fund, including the performance of the reference assets to which any derivatives are linked, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
