Correlation³ = 1.00

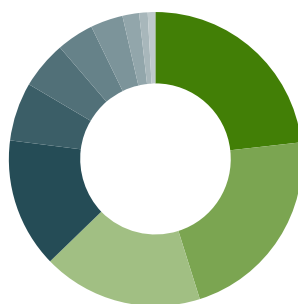

These differences may be significant.** Smaller index gains/losses and higher index volatility contribute to returns worse than the Daily Target.
