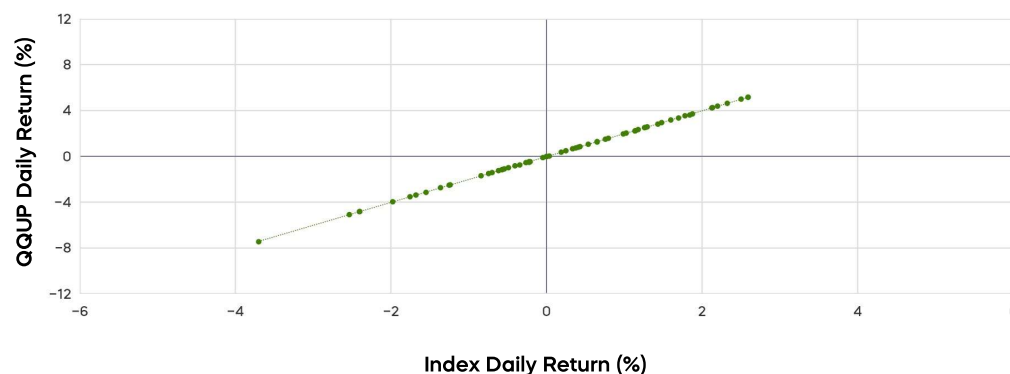

Beta⁴ = 2.00

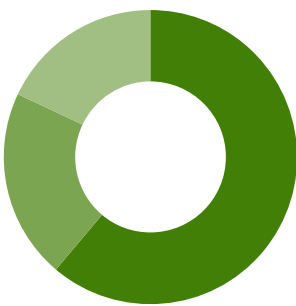
The scatter plot charts the daily NAV-to-NAV results of the fund against its underlying index return on a daily basis.
