### INDEX DESCRIPTION

The Bloomberg XRP Index is designed to measure the performance of a single XRP traded in USD. The index is constructed and maintained by Bloomberg Index Services Limited.

This ProShares ETF seeks daily investment results that correspond, before fees and expenses, to 2x the daily performance of its underlying benchmark (the "Daily Target"). For any holding period other than a day, your return may be higher or lower than the Daily Target. These differences may be significant.
